#### Purpose of this form:

This form is to be completed by the authorized representative of the Applicant and *submitted to your SBA Participating Lender*. Submission of the requested information is required to make a determination regarding eligibility for financial assistance. Failure to submit the information would affect that determination.

#### <u>Instructions for completing this form:</u>

# **Summary of Comments**

  - Note: The Application calls for the more inclusive standard of 20% "equity" ownership, rather than simple economic ownership, and we recommend using "voting security" ownership as the metric.
- **C. Q1-Q3** Applicant will respond to these questions on its own behalf and on behalf of any 20% or more direct and indirect owner (e.g. Applicant will need to respond that none of its 20% or more direct and indirect owners are presently involved in any bankruptcy).
